Not surprisingly, this exact same developer (WLB) has tried this with Harris Farm before at the Bronte RSL site (<http://savebrontevillage.com/>). Once rezoned they submitted plans to build a much larger development (apartments on top of a Harris Farm) and requested additional changes to the planning controls. Unfortunately this sounds all too familiar.

If Eastern Rd is rezoned it would allow this exact scenario to happen as the current plans are "concept plans only" and they are not at all obligated to use them.
